
Specifications for Belts and Other Holster Items

Sam Browne Gun Belt

- **Manufacturer/Model:** 3" Gould & Goodrich, PDY Model, Sam Browne Gun Belt **(NO Substitutions will be accepted)**
- **Additional features:**
 - MUST be a full three inches (3") wide, constructed from high gloss clarino and laminated to a ten (10) oz. liner;
 - Two-ply construction
 - Fully-lined with full-grain leather
 - Buckle safe and solid brass buckle
 - Buckle tab and belt loop shall be made with clarino
- **Hardware:**
 - Polished solid brass buckle
 - Hook shall be steel with a baked semi-gloss enamel finish
- **Color/Finish:**
 - Black with High-Gloss finish
- **Sizes:** shall range from twenty-eight inches (28") to sixty inches (60")
- **Construction and Workmanship:**
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
 - Belt shall be fully stitched and there shall be seven (7) rows of size adjustment holes seven-eighths inches (7/8") apart—from center of each hole—beginning approximately four inches (4") from end of belt.
- **Order Requirements**
 - No minimum quantity will be required for each order placed
 - Each belt shall be packaged individually

Vertical Magazine/Clip Case

- **Manufacturer/Model:** Gould & Goodrich, PEL Model, Vertical Double Magazine/Clip Case **(NO)**

Substitutions will be accepted

- **Additional features:**
 - Molded
 - Slotted back with protective flap
 - Material shall be durable lightweight high gloss clarino bonded to a copolymer.
 - Material shall be adhered to with permanent cement.
 - Pouch shall be thermos-formed to keep its shape.
- **Hardware:**
 - Military spec hidden snap
- **Color/Finish:**
 - Black with High-Gloss/Clarino finish
- **Additional Considerations:**
 - Must fit three-inch (3") belt loop
 - Must fit Glock-31 magazine
- **Construction and Workmanship:**
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
 - The thread shall be Dacron polyester, with a minimum of six (6) stitches per inch.
- **Order Requirements**
 - No minimum quantity will be required for each order placed
 - Each case shall be packaged individually

Handcuff Case

- **Manufacturer/Model:** Gould & Goodrich, PEM Model, Handcuff Case **(NO Substitutions will be accepted)**
- **Additional features:**
 - Molded to fit standard Smith & Wesson and peerless style handcuffs
 - Slotted back with protective flap
 - Material shall be high gloss clarino and molded to a durable synthetic
- **Hardware:**
 - Military spec hidden snap
- **Color/Finish:**
 - Black with High-Gloss/Clarino finish
- **Additional Considerations:**
 - Must fit three-inch (3") belt loop
- **Construction and Workmanship:**
 - Minimum of four (4) oz. leather lining shall be installed on the back of molded pockets to protect belt from handcuffs.
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
 - The thread shall be Dacron polyester, with a minimum of six (6) stitches per inch.
- **Order Requirements**
 - No minimum quantity will be required for each order placed
 - Each case shall be packaged individually
- **Order Fulfillment**

- **Additional features:**
 - Slotted belt loop with protective flap
 - Material shall be high gloss clarino and molded to a durable synthetic
- **Hardware:**
 - Military spec hidden snap
- **Color/Finish:**
 - Black with High-Gloss/Clarino finish
- **Additional Considerations:**
 - Must fit three-inch (3") belt loop
 - Must fit Freeze +P spray—2 oz. container
- **Construction and Workmanship:**
 - Minimum of four (4) oz. leather lining shall be installed on the back of molded pockets to protect belt from canister.
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
 - The thread shall be Dacron polyester, with a minimum of six (6) stitches per inch.
- **Order Requirements**
 - No minimum quantity will be required for each order placed
 - Each holder shall be packaged individually
- **Order Fulfillment**
 - Orders must be fulfilled within thirty (30) days of receipt of approved purchase order from the State.

Belt Keeper #1

- **Manufacturer/Model:** Gould & Goodrich, OZT Model, Belt Keeper **(NO Substitutions will be accepted)**
- **Additional features:**
 - Material shall be high gloss clarino laminated to six (6) oz. black leather
 - Shall be three-quarters inch (3/4") wide, with two snaps
- **Hardware:**
 - Brass or nickel must be available – purchase order shall distinguish which one required with order.
- **Color/Finish:**
 - Black with High-Gloss/Clarino finish
- **Additional Considerations:**
 - Must fit three-inch (3") belt loop
- **Construction and Workmanship:**
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
 - Stitch line shall be one-eighth inches (1/8") from edge
 - High gloss clarino shall be permanently bonded.
- **Order Requirements**
 - No minimum quantity will be required for each order placed
 - Each keeper shall be packaged individually

Belt Keeper #2

- **Manufacturer/Model:** Gould & Goodrich, PEH Model, Belt Keeper **(NO Substitutions will be accepted)**
- **Additional features:**
 - Material shall be high gloss clarino laminated to six (6) oz. black leather
 - Shall be three-quarters inch (3/4") wide, with two hidden snaps
- **Hardware:**
 - Brass or nickel must be available – purchase order shall distinguish which one required with order.
- **Color/Finish:**
 - Black with High-Gloss/Clarino finish
- **Additional Considerations:**
 - Must fit three-inch (3") belt loop
- **Construction and Workmanship:**
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
 - Stitch line shall be one-eighth inches (1/8") from edge
 - High gloss clarino shall be permanently bonded.
- **Order Requirements**
 - No minimum quantity will be required for each order placed
 - Each keeper shall be packaged individually

Baton/ASP Holder

- **Manufacturer/Model:** Gould & Goodrich, PXO Model, Baton/ASP Baton holder **(NO Substitutions will be accepted)**
- **Additional features:**
 - Holder to be slot type belt loop with an opening at the top and closed at the bottom
 - Holder to fit twenty-one inch (21") expandable police baton with foam handle
 - Pouch front shall be of high gloss clarino polymer laminate joined to a Kydex thermos-molded material
- **Hardware:**
 - None
- **Color/Finish:**
 - Black with High-Gloss/Clarino finish
- **Additional Considerations:**
 - Must fit three-inch (3") belt loop
- **Construction and Workmanship:**
 - The thread shall be Dacron polyester, with a minimum of six (6) stitches per inch.
 - All edges shall be beveled and stained black with a water resistant edge dye that shall not come off on clothing.
- **Order Requirements**
